 - Avoid any activity, investment or interest that might reflect unfavourably on the reputation of Arya Offshore.



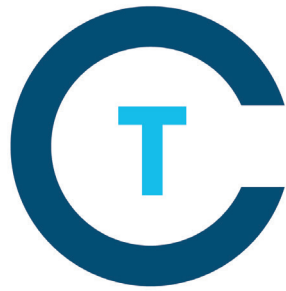
